Crime in Delaware: 2010 – 2014 is the official report of serious crimes known to law enforcement from 2010 through 2014. The report provides extensive data about crime at the state and county levels. This supplement continues to reflect an evolving effort within the *Crime in Delaware* reporting process to provide extensive crime data about the City of Wilmington.

The methods used to prepare and analyze Wilmington’s data are the same as those described in the main *Crime in Delaware* report, with one exception: data for Wilmington’s two enforcement agencies—the Wilmington Police Department and the Wilmington Fire Marshall—were first merged before analyzing the city’s data.

In this supplement, tables and figures with summary level data about offenses, clearances, and arrests are presented first. These are followed by detailed data tables with counts of offenses, clearances, and adult and juvenile arrests (Tables 3 – 6). Summaries of key findings from each level of data are also included and precede the two sections.

Note to the reader

Data for a calendar year are not considered final for the purposes of the *Crime in Delaware* report until offense counts become sufficiently stable, usually 12 – 15 months after the end of that year. Therefore, final data are provided for the 2010 – 2013 period and preliminary data for 2014. To illustrate long term trends, final data for the years 2003 through 2009 are included in the figures.

Wilmington Serious Crime At-a-Glance 2010 – 2014

Overall, 2,746 fewer Group A offenses were reported in Wilmington in 2013 compared to 2010, a decline of 18.2%. Preliminary data for 2014 suggest an additional decline of about 270 offenses (see Table 1 and Figure 1). All four major crime categories were lower in 2013 compared to 2010, with the greatest declines for Drug/Narcotic Offenses (30.2%) and Other Property and Social Offenses (24.6%). Violent Offenses and Serious Property Offenses declined during this period by 19.8% and 11.8%. All categories showed modest declines between 2013 and 2014 (generally, 2% or less; Drug Offenses, however, did decrease by about 7%). Long term trends since 2003 can also be seen in Figure 1. The number of homicides in 2014 (27) is the highest of the five year period.

The most frequently reported offenses in the city were Assault; Destruction, Damage, and Vandalism of Property; Larceny; Drug/Narcotic; Burglary; and Weapon Law Violations. Assault, Drug Offenses, and Destruction/Damage/Vandalism showed distinct downward trends from 2003 to 2014 (see Figure 2). The patterns for the other three offenses were more mixed. Long term trends since 2003 can be seen in Figure 2.

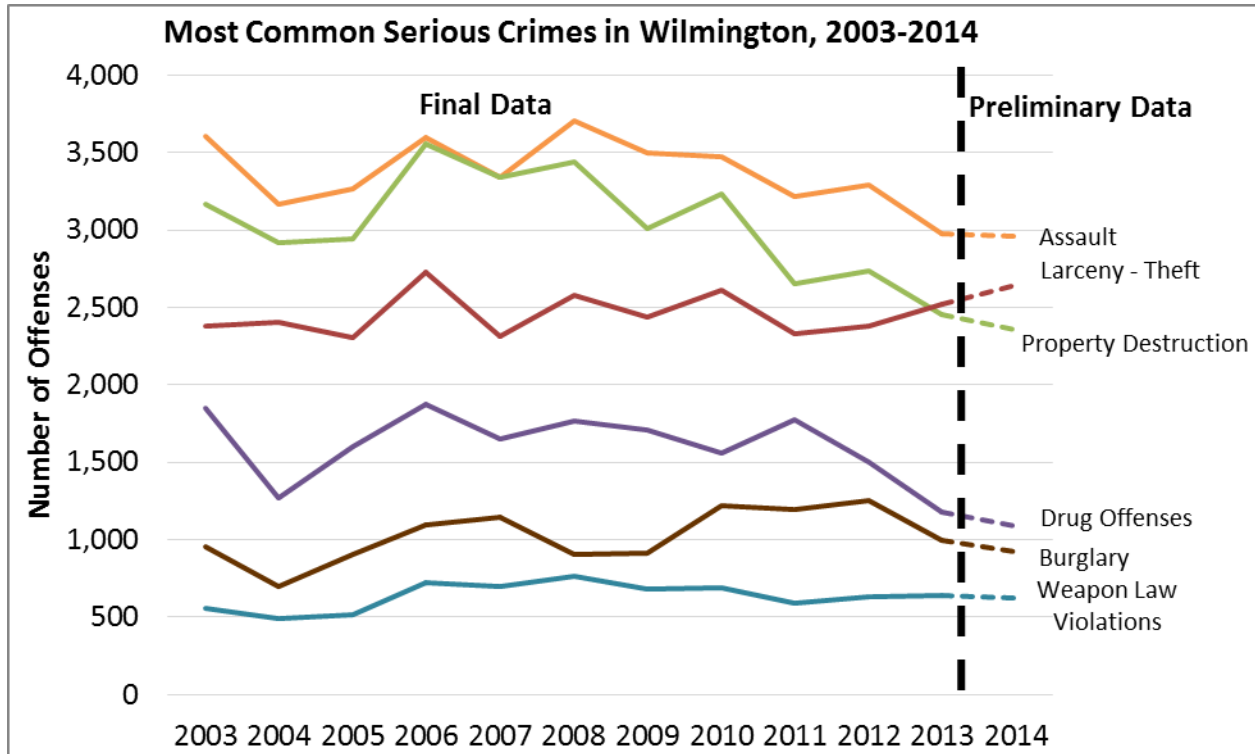
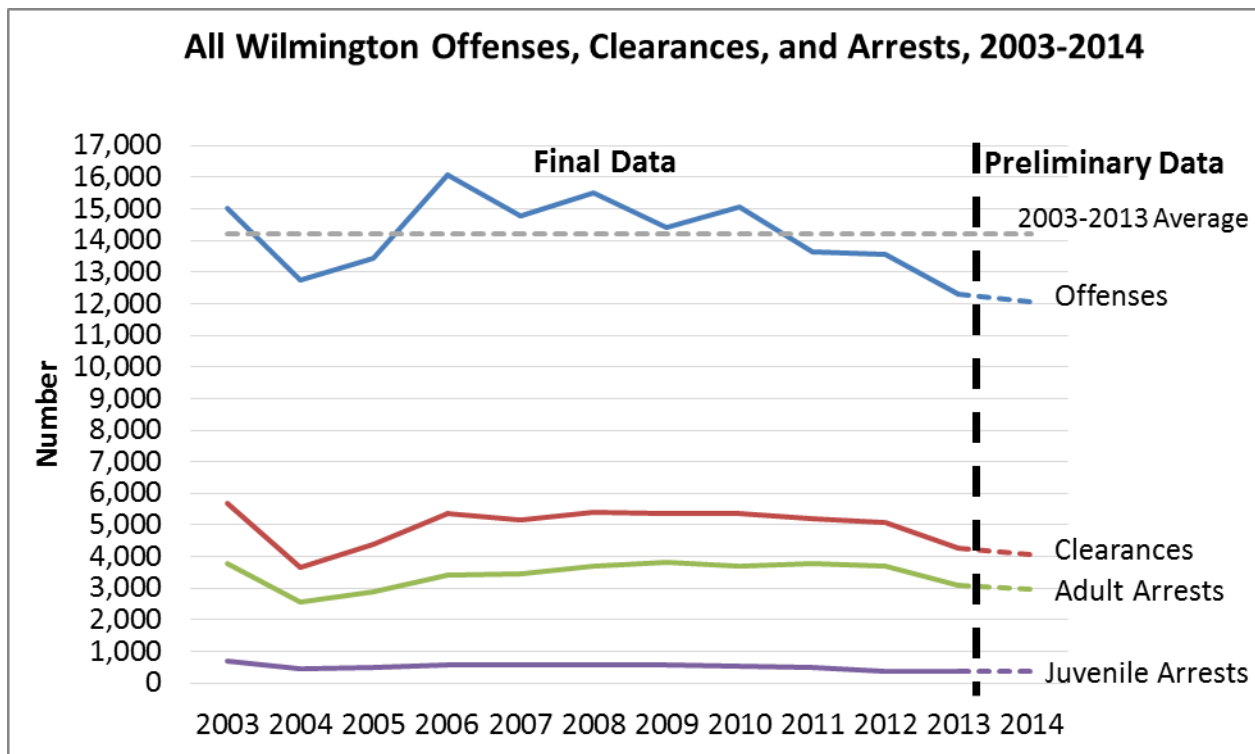


Figure 3: All Wilmington Offenses, Clearances, and Arrests, 2003 – 2014

Based on 2014 preliminary data, offenses in all crime categories were cleared at rates generally comparable to the rates from 2010 through 2013 (see Table 1 and Figure 3). Overall, about one-third of all offenses committed in 2014 were cleared by the end of the calendar year. Long term clearance trends can also be seen in Figure 3.

The number of juvenile arrests showed a sharp downward trend during this period (a 31% decrease overall). The number of total adult arrests was about 20% lower (see Table 2 and Figure 3). Long term trends in arrests can also be seen in Figure 3.

Figure 1: Serious Crime in Wilmington by Category, 2003 – 2014

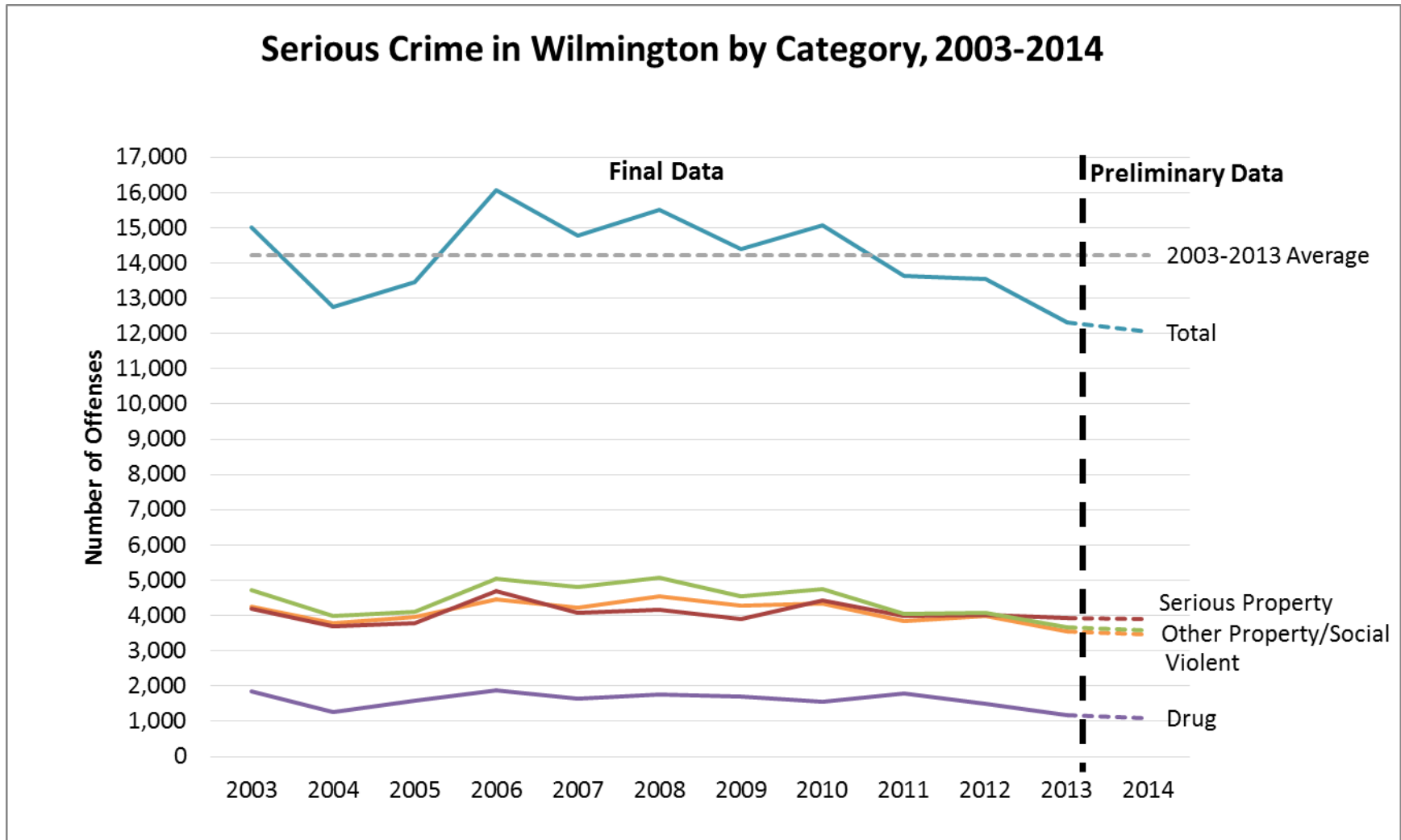

Figure 2: Most Common Serious Crimes in Wilmington, 2003 – 2014

A Detailed Look at Crime in Wilmington

The following section provides more detailed information about serious crime in Wilmington. Included is a summary of notable findings for specific crimes within the four crime categories (Violent Offenses, Serious Property Offenses, Drug/Narcotic Offenses, Serious Property Offenses) along with tables that provide detailed counts of offenses, clearances, and adult and juvenile arrests.

Notes to the Reader

Data for a calendar year are not considered final for the *Crime in Delaware* report until offense counts become sufficiently stable, usually 12 – 15 months after the end of that year. Therefore, final data are provided for the 2010 – 2013 period and preliminary data for 2014.

Graphic figures that incorporate final and preliminary data are include as appropriate to illustrate trends in the data.

Please use caution when comparing Wilmington’s data to data for other jurisdictions and geographic areas. Crime data are best understood in the context of other data.

An important consideration to keep in mind:

- In drawing conclusions about changes between 2014 preliminary data and the final data from prior years, be aware that some crimes (e.g., Fraud, Forgery/Counterfeiting, Arson, Homicide) are more prone to delayed reporting to law enforcement agencies or the filing of charges than other crimes.

Violent Offenses

- The number of Criminal Homicides (27) was the highest of the report period.
- Kidnapping/Abduction and Forcible Sex Offenses (both lower frequency crimes) were about 40% lower in 2014 as compared to 2010.
- Assault and Robbery offenses were about 14% and 39% lower in 2014 compared to 2010.
- Assault offenses that involved the use of firearm were about 29% higher in 2014 compared to 2010. Robbery offenses decreased about 43% during this period. While not reported in the NIBRS data, most criminal homicides in 2014 involved the use of a firearm.

Serious Property Offenses

- Burglary offenses were about 24% lower compared to 2010.
- The number of all Larceny offenses was up about 1%. Within that subcategory of crime:
 - The number of Theft from a Building offenses was about 8% higher than 2010 and the highest of the period.
 - The number of Theft from a Motor Vehicle offenses was about 6% lower than 2010.
- The number of Motor Vehicle Theft offenses was down about 41% compared to 2010, the lowest amount of the period.

Drug/Narcotic Offenses

- Overall, the number of offenses in this category in 2014 was about 30% lower than 2010. Drug Equipment offenses were about 49% lower during this period. Both totals reflected lows for the report period.

Other Property and Social Offenses

- The number of Fraud offenses was about 28% lower in 2014 compared to 2010. This decrease was largely driven by a substantial decline in Impersonation offenses (about 43%).
- The number of Destruction, Damage, Vandalism of Property offenses in 2014 was the lowest of the report period and reflects a roughly 26% decrease since 2010.
- Weapon Law Violations were about 8% lower compared to 2010 and the second lowest number of the report period.
