

Crime in Delaware 2020 – 2024 is the official report of serious crimes known to Delaware law enforcement from 2020 through 2024. The report provides extensive data about crime at state and county levels. This supplement reflects an evolving effort within the Crime in Delaware reporting process to provide extensive crime data about the City of Wilmington.

The methods used to prepare and analyze Wilmington’s data are the same as those described in the main Crime in Delaware report, with one exception: data for Wilmington’s two law enforcement agencies—the Wilmington Police Department and the Wilmington Fire Marshall—were first merged before analyzing the city’s data.

In this supplement, tables and figures with summary level data about offenses, clearances, and arrests are presented first. These are followed by detailed data tables with counts of offenses and clearance percentages, and adult and juvenile arrests (Tables 3 – 14). Summaries of key findings from each level of data are also included and precede the two sections.

Cautionary Note: As discussed in the full Technical report and Executive Briefing, caution should be used when comparing trends involving 2020/2021 data and in interpreting the 2020 to 2024 differences. As national, regional, and international research has emerged, the COVID-19 pandemic and subsequent State of Emergency declarations, court closings, and travel restrictions within the State of Delaware likely had differential impacts on crime and arrests. The Center intends to explore these potential impacts on trends before the next cycle of Crime in Delaware reports in 2026.

Note: Use caution when interpreting data for the Fraud crimes of Identity Theft and Hacking/Computer Invasion. Issues with the way these crimes were coded in the downloaded data accounts for the drastic swing in the counts for these crimes. The SAC does not yet have a means for correcting these counts.

Wilmington Serious Crime At-a-Glance 2020 – 2024




Figure 2: Serious Crime in Wilmington by Category, 2013 – 2024 (Categories Only)

Overall, 1,415 fewer Group A offenses were reported in Wilmington in 2024 compared to 2020, a decline of 15.1%, continuing a long overall downward trend (see Table 1 and Figure 1). All major crime categories were lower in 2024 compared to 2020, with the greatest declines in Drug Offenses (44.5%), Serious Property Offenses (10.6%), and Violent Offenses (15.8%). See Figure 1 for long-term trends since 2013. Long-term trends just for the four offense categories are presented in Figure 2 to allow for easier differentiation between those categories.

The most frequently reported offenses in the city were Assault; Property Destruction/Vandalism; Larceny/Theft; Motor Vehicle Theft; Drug/Narcotic; Weapon Law Violations, and Burglary (see Figure 3)¹. All six offenses experienced declines when comparing 2024 to 2020. Drug/Narcotic Offenses, Burglary, and Weapon Law Violations saw the largest decreases (44.5%, 32.3%, and 30.4%, respectively). Assault and Larceny/Theft experienced significant declines (12.5% and 9.4%, respectively), with a slight reduction in Property Destruction/Vandalism (2.7%).

The number of homicides in 2024 was around 20% lower compared 2020, but around 110% higher than 2023's reporting-period low of 12².





Figure 4: All Wilmington Offenses, Clearances, and Arrests, 2013 – 2024

2024 offenses in all main crime categories were cleared at rates comparable to those from 2020 through 2023 (see Table 1 and Figure 4). Overall, 32.6% of all offenses committed in 2024 were cleared by the end of the calendar year, with 52.3% of Violent Offenses cleared and 82.7% of Drug Offenses cleared. Long-term clearance trends as recorded by the end of the calendar year can be seen in Figure 4.

The number of adult and juvenile arrests decreased from 2020 to 2024 (23.9% and 20.9%, respectively). Yearly arrest totals vary from year to year. Adult and juvenile arrest totals across all four crime categories are substantially lower compared to 2020. Long term trends in arrests can also be seen in Figure 4.

Drug Offense Changes: In 2015, Delaware decriminalized certain marijuana possession offenses. The federal government still records these offenses as criminal, so they remain in the Drug Offense totals in this report. An arrest may not be made for possession offenses deemed "civil offenses" by Delaware.

¹ While Motor Vehicle Theft ranked in the top six most frequently occurring offenses in 2024, historically its frequency has lagged behind that for Burglary. As a result, Motor Vehicle Theft is not included in Figure 9.

² Per the State Bureau of Identification, the Delaware NIBRS program manager, 1 Murder/Non-Negligent Manslaughter for Wilmington had not been finalized by the FBI's final data submission deadline. As a result, this incident was not included in the data files downloaded and analyzed for Crime in Wilmington. It will be included in SBI's next data file update and the corrected 2024 values will be updated in the 2025 Crime in Wilmington report.

Figure 1: Serious Crime in Wilmington by Category, 2013 – 2024



A Detailed Look at Crime in Wilmington

The following section provides more detailed information about serious crime in Wilmington. Included is a summary of notable findings for specific crimes within the four crime categories (Violent Offenses, Serious Property Offenses, Drug/Narcotic Offenses, Other Property and Social Offenses). New this year—tables that present offense, clearance, and arrest data have been modified to reflect the approach taken in the *Crime in Delaware* report: offense counts and clearance percentages are presented together, and all data are grouped based on the four main crime categories. The data tables are presented on pages 11 – 24.

Violent Offenses

- The number of 2024 Criminal Homicides is roughly double the number in 2023 (which had the reporting period low of 12), but down from the record set in 2021 (40).
- Forcible Sex Offenses were two-thirds lower in 2024 as compared to 2020, and at the lowest level for the 5-year report period.
- Robbery and Assault Offenses both decreased (33.8% and 12.4%, respectively) compared to 2020.
- Assault Offenses that involved the use of a firearm were 36.9% lower compared to 2020; Robbery Offenses involving a firearm were down 13.5%.

Note: In 2019 the FBI began including Vehicular Homicides under the Criminally Negligent Manslaughter category. Those offenses were not previously included in the NIBRS Homicide summary totals. This change has had minimal effect on Wilmington Homicide totals to date.

Serious Property Offenses

- Burglary offenses were 32.3% lower in 2024 compared to 2020.
- The number of all Larceny/Theft Offenses in 2024 was 9.4% lower compared with 2020.
- Within that subcategory of crime:
 - Theft of Motor Vehicle Parts/Accessories climbed 58% from 2024 to 2020 (with the majority of this increase occurring in 2021) but were stable compared to 2023.
 - The number of Theft from a Building Offenses was 7.7% lower than 2020.
 - The number of Shoplifting Offenses in 2024 decreased 16.4% from 2020, 22.3% compared to 2023.
 - The number of Theft from a Motor Vehicle offenses decreased 22.2% since 2020.
 - Motor Vehicle Theft offenses experienced a 15.4% increase compared to 2020, but a 27.8% decrease since 2023.

Drug/Narcotic Offenses

- Total Drug Offenses in Wilmington were down 44.5% overall from 2020 to 2024.
- Drug/Narcotic Possession offenses decreased 48.6%, and Drug Equipment offenses, 14.1%.

Other Property and Social Offenses

- The number of total Fraud Offenses was down 16.1% from 2020 to 2024.
- Property Destruction/Vandalism offenses were slightly lower (2.7%) in 2024 compared to 2020.
- Weapon Law Violations were 30.4% lower compared to 2020.
